This product is tank mix compatible with most fertilizers and pesticides. However, due to variability in water sources and pesticide formulations, a compatibility test is recommended.

Golf Course Greens, Tees, and Fairways Sports Turf Lawns

For optimal results, apply 10 to 20 fl oz per acre (0.25 to 0.5 fl oz per 1,000 sq ft) monthly for cool season turf; or 15 to 30 fl oz per acre (0.35 to 0.7 fl oz per 1,000 sq ft) for warm season turf. May be tank mixed with other soil applied products. Dries safely on the leaf surface, but for best results water into soil profile as soon as possible.

Ornamentals

Mix 16 to 32 fl oz in 100 gal of water. Spray to the point of runoff or drench into soil.
